

ANTI-DISCRIMINATION POLICY

6.16. The appearance of students and employees of the University must be accurate and correspond to the business educational environment and is regulated by the corresponding Regulation approved by the Rector of the University ([Устав ОшГУ](#))

6.27. University students are required to:

1. Comply with this Charter, internal regulations, rules of residence in a hostel and other local acts of the University;
2. Perform all types of tasks stipulated by the curricula, master knowledge, skills and skills within the prescribed time frame;
3. It is mandatory to attend all types of educational activities defined in the curriculum, unless otherwise provided by local acts of the University;
4. Observe the moral and moral standards of society;
5. Protect the property of the University, compensate for the material damage caused;
6. Have a scientific and cultural outlook necessary for a future specialist of high qualification;
7. Respect the honour and dignity of teachers and students;
8. Perform other duties stipulated by the legislation of the Kyrgyz Republic. ([Устав ошгу](#))

6.30. 4.13. The teacher does not show his feelings, emotions, behavior, sympathy and antipathy to other employees and students. He knows how to hold himself in all situations and follows moral standards. Deliberately changing the name, name of the student, social shortcomings, ridicule, bullying, humiliation of the character, body and life of the student do not comply with the standards of pedagogical ethics. 4.21. OSHU leadership strongly condemns corruption, forcing students to act corruption and creating special conditions for corruption, as well as whether to remain in office or not, is on the
