ACCESSIBLE ENVIRONMENT

1. Information about the availability of equipped classrooms, facilities for classes adapted for the use of persons with disabilities

Osh State University provides an opportunity to study on adapted educational programs for people with disabilities.

Students with mobility limitations study in academic buildings and stay in dormitories that provide conditions for the stay and education of people with disabilities (conditions of unimpeded, safe and comfortable movement of students with limited mobility).

For the disabled and persons with disabilities, who have locomotor disorders, training is provided in buildings, medical organizations that have material and technical conditions that provide students with unhindered access to educational and other rooms of the organization, as well as their stay in these rooms (availability of ramps, handrails, widened doorways).

For persons with disabilities, there is a compulsory escort by security representatives.

People with disabilities have the opportunity to receive treatment and rehabilitation services in the medical clinic of the university.

The formation of an inclusive educational environment is also provided through the development of volunteer movement, the involvement of students with disabilities in extracurricular activities, social projects, creative activities, etc.

All classrooms are accessible for students with limited mobility, there is a ramp at the entrance to the building and on the 1st floor, also all doorways in classrooms are widened, on the 1st floor there is a separate toilet for the disabled people.

2. Information about the conditions of health care for students with disabilities

3. Information on the availability of sports facilities adapted for people with disabilities.

For students with disabilities, the University establishes a special procedure for the development of disciplines (modules) in physical culture and sports on the basis of the principles of health conservation and adaptive physical Training sessions are conducted by physical education faculty members with appropriate training, in specially equipped sports, gyms, exercise or outdoors. Sports equipment meets the requirements of accessibility, reliability, durability, and convenience to create a barrier-free environment in sports halls.

4. Information on the means of education and upbringing of persons with disabilities

Osh State University has the necessary equipment of education and training facilities of students, including for persons with disabilities.

In order to provide an individual approach to students with disabilities and HIA in accordance with their needs and abilities, the University provides for the use of devices, tools, equipment and specialized equipment to organize of the educational process.

At Osh State University, the organization of extracurricular educational activities and youth policy is based on modern requirements to optimal socio-cultural environment that promotes the formation of students ' social and communication skills, norms and values of personal and professional culture. Extracurricular activities are organized in according to the principle of educational integration: students with disabilities are included in the activity environment together with normative-developing peers.

When planning activities, the need to involve students with disabilities and HIA without separating them out as a separate group is taken into account. The University constinuously supports and funds student projects aimed at expanding the information field, including about people with disabilities.

Work is being done to maintain and further develop a tolerant socio-cultural environment necessary to form a civil, legal and professional position of participation, complicity, the willingness of all members of the collective to communicate and cooperate, and the ability to tolerate social, personal and cultural differences.

In order to implement of personal, individualized, social support of students with disabilities, a form was been introduced: the volunteer and tutor movement of students. One of the socially significant directions of the volunteer movement of students of the University is gratuitous assistance in the socialization and adaptation of disabled people and persons with disabilities, support for inclusive education of students with disabilities and persons with disabilities, in a tolerant socio-cultural environment.

5. Information about the nutrition conditions of students with disabilities

Canteens and cafes located in educational and laboratory buildings are provided for students ' meals. The following food facilities are equipped to provide access for the disabled and people with disabilities - Osh State University Medical Clinic, OGKB, OMOKB. OMODKB.
