Regulations on the OshSU Youth Committee

I. General Provisions

1.1 The structure of student government at OshSU is the Youth Committee (hereinafter referred to as the Committee). Youth Committee of OshSU - structural division of school which within the limits of its competence realizes the state youth policy. It was created on the basis of the Decree of the President of the Kyrgyz Republic "On the development of state youth policy of the Kyrgyz Republic" and is based on the laws of the Kyrgyz Republic "On Education", "On the basis of state youth policy. ", the Charter of OshSU, the Concept of Education, this Regulation and other normative acts.

1.2 The committee consists of teachers, graduate students and students aged 14 to 35 years old;

1.3 Committee works in close cooperation with republican bodies of executive power and local government, public and non-governmental youth organizations;

II. Aims and purposes of committee

The main goals and objectives of the Youth committee are:

2.1. implementation of the Law of the Kyrgyz Republic "On the Fundamentals of State Youth Policy";

2.2 Implementation of state youth policy of the Kyrgyz Republic within the competence of Osh State University;

2.3 Ensuring the implementation of the National Program "Youth of Kyrgyzstan;

2.4 Establishing and strengthening ties with other universities of the Kyrgyz Republic;

2.5 Periodic organization of festivals, forums, competitions, scientific and practical conferences, seminars, trainings, meetings, lectures, interviews, debates, discussions, cultural and sports events among students, as well as regional and national events. Active participation.

; 2.6. Encouragement of projects, programs and initiatives of young entrepreneurs, assistance in youth employment and protection of legal, social and economic interests of students, organization of student construction teams;

2.7. Development and implementation of social programs and projects for all-round development of young people in cooperation with public, private and commercial entrepreneurs, as well as international organizations;

2.8. Assistance to educational work, organization of cultural events for students, development of physical culture and sports among the youth;

2.9. to protect the rights and legitimate interests of young people, taking into account the socio-economic, cultural and demographic characteristics of the country;

2.10. Contribute to moral, intellectual, cultural and aesthetic development of young people and instill patriotism in them.

III. Rights of the Committee

3.1 Make suggestions to school administration on main priorities and directions of youth policy realization at school and develop mechanisms of their realization as well as take part in regional and republican state events on youth policy;

3.2 Make independent decisions within their competence if they do not contradict the legislation of the Kyrgyz Republic;

3.3 Participate in activities to support young people in difficult socio-psychological, pedagogical, legal and life situations;

3.4 Sanitary, electrical equipment of educational buildings, dormitories OshSU. take part in special raids to check safety;

3.5 Conduct preventive explanatory and educational work among students;

3.6 To put on the agenda of the committee meetings the students who have low quality and absolute performance in the educational process and do not comply with the rules of conduct in public places;

3.7 Based on the results of the year and holidays (World Youth Day, International Students Day, Defender of the Fatherland Day, International Women's Day, etc.) Best achievements in the educational process, high results in sports competitions and active participation in cultural and social events to make proposals to the university

administration to award students, graduate students, young teachers for their participation (scholarships, cash awards, diplomas, etc.);

3.8 Provide methodological coordination of educational work to youth committees of faculties that are part of the OshSU Youth Committee, within their competence;

3.9 Involve sponsors and organizations on a voluntary and contractual basis to organize activities related to youth policy;

3.10. There are educational-methodical centers, sports sections, creative groups, etc. among students to promote the creation of organizations;

3.11. Newsletters on youth affairs, educational and methodical, etc. prepare materials.

4.16. The board considers and discusses the main issues of state and school youth policy;

4.17. Members of the Board shall be approved by the school principal at the suggestion of the chairman;

4.18. Decisions of the Board shall be made by a majority vote of the Board members.

V. Financial and material and technical resources of the Committee

5.1 Funding for the activities carried out by the Committee shall be in accordance with the legislation of the Kyrgyz Republic, the budget of the school, grants, projects, sponsors, etc. etc. at the expense of funds;

5.2 In carrying out activities related to the Committee, the active members of the Committee shall use the material and technical resources allocated by the administration of the University.

VI. Reorganization and liquidation of the Committee

6.1 Termination of the Committee shall be accomplished in one of the following ways:

a) incorporation into another structure;

b) reorganization;

c) dissolution of the structure;

6.2 Termination of the Committee shall be carried out by decision of a special commission formed by the Rector of the University;

6.3 Documents related to the activities of the Committee and termination of the Committee shall be stored and used in accordance with the Law of the Kyrgyz Republic "On the National Archive Fund of the Kyrgyz Republic".

Duties of heads of sectors of the OshSU Youth Committee

I. Duties of the Head of the Educational Sector

1. work closely with the OshSU Provost for Academic Affairs and the staff of the Department of Education and Information (DEI);

2. Coordinate checking group logs by the educational sectors in the departments, verifying the list of students who have missed 60 hours of classes without cause, and notifying the Dean's Office, Education Department, and OID of this;

3. organization of subject circles in coordination with the departments;

4. Together with the dean's office, identify the best students and place their pictures on the honor board;

5. Ranking of students according to the results of the contest-session and placement in the wall newspaper;

6. To publish in the "Spikes" section of the wall newspapers of the faculty students who are the most late, miss

classes without reason and gave poor results at the end of the examination session;

7. In conjunction with the Dean's Office, nominate the best students for an award.

II. Duties of the Head of the Science Sector

1. closely cooperate with the Vice-Rector for scientific work OshSU;

2. inform students about the requirements for writing scientific articles, term papers, essays, dissertations through wall newspapers, seminars, trainings, newsletters;

3. organization of monthly scientific wall newspapers at the faculties;

4. organization of scientific clubs in agreement with the departments;

5. Students are invited to scientific conferences, seminars, scientific research.

IV. Management Body and Structure of Committee

4.1 Chairperson of OshSU Youth Committee is elected by OshSU students, faculty, graduate or under 35 years old.4.2 Committee members may be students, graduate students, and young faculty between the ages of 14 and 35.

Rights and Duties of the Chairperson

4.3 The Chairperson directs the overall activities of the committee;

4.4. the chairman coordinates and is responsible for the implementation of tasks and assignments entrusted to the committee;

4.5. Develops the structure of the Committee and makes changes as appropriate;

4.6. Structural heads of the Committee (Deputy, Heads of Sectors, chairmen of youth committees of faculties) act on the basis of the Regulation on functional responsibilities and rights, developed in accordance with the regulations of the committee;

4.7. Appoints acting Committee members (Deputy and Heads of Sectors), brings them to disciplinary responsibility and dismisses them from their positions in accordance with the law;

4.8 Approves the provisions on youth committees of faculties;

4.9 Gives instructions, orders and directions to active members of the Committee within his competence;

4.10. Concludes contracts and agreements related to Committee activities;

4.11. Determines the main perspective directions of the Committee activity, develops plans and prepares a report on their implementation;

4.12. Nominates a candidate to the faculty management for election or appointment as the Chairman of the Faculty Youth Committees, competitive selection;

4.13. Approves the work plans of the Chairmen of the Youth Committees of the Faculties and hears the reports on their work once a semester;

4.14. Supervises the targeted and effective use of the Committee's material and technical resources;

4.15. The Committee is entitled to establish a board consisting of a chairman and a deputy chairman. Members of the Board may be representatives of the school administration (vice-rectors, deans, heads of departments), trade unions, members of youth committees of faculties, and student councils of dormitories;

Taking part in weekly events;

6. Organization of meetings with scientists, graduate students.

III. Responsibilities of a sports industry leader

1. work closely with the Osh State University Physical Education Department staff;

2. Formation of university (faculty) teams (boys, girls) in major sports (basketball, volleyball, tennis, chess, checkers, soccer, ordo, toguz korgool, etc.);

5. Active participation of students in national and regional debate tournaments among universities;

V. Duties of the head of the cultural organization sector
