

Regulations on hostels of Osh State University

Regulations on hostels of Osh State University

(The regulation was approved at the 6th meeting of the Academic Council of Osh State University on February 15, 2010)

I. General Provisions

- 1.1. Dormitories of Osh State University - a social facility on the basis of a university;
- 1.2. Students who come to the hostel from remote areas and study in full-time and part-time departments of Osh State University, who need a hostel, can live on a one-year contract;
- 1.3. The University provides residents with socially necessary conditions (toilet, shower, etc.) and provides them with inventory;
- 1.4. The University ensures timely supply and uninterrupted operation of power supply, gas, water and heating systems in the hostel;
- 1.5. In the event of an increase in prices for utilities in the city, the fee for the contract for dormitories will also increase;
- 1.6. Dormitories of Osh State University are part of the upbringing department in terms of organization and upbringing work;
- 1.7. The coordinator of the hostel of Osh State University, the commandants of the hostels are recommended by the director of the education department, appointed by the rector and act in accordance with these regulations.

II. Accommodation of students in hostels

- 2.1. Students are accommodated in hostels from August 25 to September 10 at the beginning of the academic year;
- 2.2. The hostel initially accommodates junior schoolchildren from remote areas, and if there are vacancies, high school students are also accommodated;
- 2.3. The placement of students and the allocation of rooms is carried out by the Department of Education; To be accommodated in a hostel, a student must:
 - contact the rector of Osh State University;
 - signed by the dean of the faculty or his deputy for educational work;
 - get a room from the head of the education department or the coordinator of the hostel;
 - obtain permission from the head of the education department;
 - Pay for the hostel in full at the cash desk of Osh State University;
 - undergo a medical examination at the medical center of Osh State University;
 - The student has the right to live in the corresponding hostel from the moment of registration, having received a power of attorney from the coordinator of the hostels of Osh State University;

III. Duties and rights of students living in hostels

Students living in a hostel are required to:

- 3.1. Pay in advance for accommodation in the hostel and accurately and fully provide the relevant documents;
- 3.2. Fully comply with the internal order in the hostel, safety rules, correct use of electrical appliances and other items;
- 3.3. Actively participate in subbotniks and landscaping conducted by the commandant and student council;
- 3.4. Gas, water, electricity, etc. should be used economically, observe safety rules when working with gas and electrical equipment;
- 3.5. Clean up sections and rooms, keep common areas clean, take care of everything related to the hostel;
- 3.6. Unused clothing, valuables, etc. transfer of things to the warehouse (for things not transferred to the warehouse, the hostel service is not responsible);
- 3.7. Students living in a hostel must notify the commandant two days in advance that they are going on vacation or internship;
- 3.8. Be polite to the staff and residents of the hostel;
- 3.9. Expel the student from the hostel within one week after the expulsion order is issued;
- 3.10. Hand over to the commandant one of the room keys;

IV. Students living in a hostel have the right to:

- 4.1. Use the inventory and equipment of the hostel;

- 4.2. Complaint to the commandant or coordinator in case of violation of the student's rights and freedoms;
- 4.3. Together with the student council of the hostel, take care of the insulation of the premises in the winter;
- 4.4. Participate in various cultural and educational events, competitions, sports competitions held in the hostel;
- 4.5. Renovate and decorate the room in agreement with the commandant;
- 4.6. Openly express your opinion to the commandant, coordinator about the shortcomings in the hostel;
- 4.7. Students who live in a hostel, do not break the rules and maintain cleanliness in the room, can live in the next academic year at the suggestion of the commandant.

V. Residents of the hostel are not allowed.

- 5.1. Move independently from one room to another and transfer inventory;
- 5.2. Repair or relocate the power line yourself;
- 5.3. Use electric heaters in the rooms;
- 5.4. Increase the volume of the tape recorder in the next room;
- 5.5. Turn on music and walk along the corridor from 23:00;
- 5.6. Put something on the walls of the room without the permission of the student council, commandant;
- 5.7. Organize independent events without the permission of the hostel administration;
Without special permission
- 5.8. Drink, store alcohol, enter the hostel drunk;
- 5.9. Bring a stranger to the hostel, spend the night;
- 5.10. Possession and use of drugs and alcohol;
- 5.11. Use unnecessary electrical equipment;
- 5.12. Smoking in the hostel;
- 5.13. If a student is expelled from the hostel for a misdemeanor, the money will not be refunded.

Vi. Student Council of the Dormitory

- 6.1. The chairman of the student council in the hostel is appointed by the coordinator of the hostel for a period of one year at the suggestion of the commandant, with the consent of the students;
 - 6.2. The commandant appoints the leaders of each floor as advised by the student council chairman;
- Student Council Tasks:
- 6.3. Assist the commandant in placing students in hostels;
 - 6.4. Organization of educational, cultural and mass events in the hostel;
 - 6.5. Control sanitary cleanliness, technical safety, internal and external order in the hostel;
 - 6.6. Organize student safety in canteens and scheduled shifts;
 - 6.7. Control the safety of personal belongings of the hostel;
 - 6.8. Punish students who have committed serious misconduct in the hostel;
 - 6.9. Before the event, obtain permission from the commandant and the coordinator of the hostel;
 - 6.10. Control the presence of sanitary booklets in each room;
 - 6.11. Explain the responsibilities and rights of residents of the hostel;
 - 6.12. Report to the hostels living in the hostel at the end of the semester;

Vii. The commandant is obliged:

- 7.1. Fully prepare the hostel for the new academic year;
- 7.2. When placing students in hostels, on the basis of an order issued by the Education Department, students are placed in the specified room, carefully check whether the hostel has been paid in full, passed a medical examination;
- 7.3. Correct distribution of inventory for each resident;
- 7.4. Direct control over the activities of the student council and hostel staff;
- 7.5. Conduct a meeting for students on the correct use of equipment, technical means of the hostel and compliance with internal cleanliness, order, safety rules;
- 7.6. Train and guide students;
- 7.7. Timely inform the dean's office, education department and parents about students who are on the wrong path;
- 7.8. Hear the watchman's report every day and act accordingly;
- 7.9. Ensure the cleanliness of the territory of the hostel and landscaping;
- 7.10. Organization of various entertainment events in the hostel;

- 7.11. Communicate with students and resolve student complaints;
- 7.12. Regularly monitor the normal operation of heating, gas, electricity and water supply systems in the hostel;

VIII. The Commandant has the right:

- 8.1. Organize useful consultations and meetings with famous people, specialists;
- 8.2. Submit a proposal to dismiss a hostel employee if he does not fulfill his duties or acts in violation of the law;
- 8.3. Warn the student in case of violation of the internal regulations of the hostel, exclude him from the hostel in agreement with the members of the student council;
- 8.4. If necessary, transfer students from one room to another;
- 8.5. Give recommendations to the administration on improving the conditions in the hostel;

IX. The guard (watchman) is obliged:

- 9.1. The security guard arrives 15 minutes earlier, inspects the hostel once, and then guards;
- 9.2. Check residents' passes regularly;
- 9.3. Keep outsiders out of the hostel;
- 9.4. If a student asks to admit a relative or friend to the hostel, leave a document on duty, indicate which room to enter, write in a journal, and then give permission;
- 9.5. Close the door of the hostel no later than 22:00 and inform the commandant of the list of students who came after the door was closed;
- 9.6. From 23:30 check the complete blocking of gas and water pipes on the floors;
- 9.7. Report to the commandant about the events that took place during his protection;

Note: After 18:00, if a stranger is admitted without a pass or breaks the law while on guard duty, he will be warned, and the second time he will be fired.

X. The coordinator of the hostel of Osh State University should:

- 10.1. Develop a plan of annual events held in the hostel at the beginning of the academic year, approve it by the director of the education department and send it to the commandants, chairmen of student councils;
- 10.2. At the beginning of the new academic year, check the repair and sanitary condition of the hostels;
- 10.3. Place students in a hostel and carefully check the full payment of the contractual fee for accommodation, medical examination, and then issue a residence permit;
- 10.4. Communicate with residents and respond to letters and complaints from students;
- 10.5. Organize special raids to check the sanitary, electrical safety of hostels;
- 10.6. Control the targeted and economical use of the material and technical means of the hostel, gas, heating, power grids;
- 10.7. Organize regularly competitions, discussions, cultural and sporting events among the hostels;
- 10.8. In case of problems in the hostel, inform the director of the education department;
- 10.9. Receive the student council report at the end of the semester;

XI. The coordinator of the hostel of Osh State University has the right to:

- 11.1. Appoint the chairman of the student council of the hostel at the suggestion of the commandant;
- 11.2. Approve the action plans of the Student Council and directly monitor their implementation;
- 11.3. At the end of the academic year and in connection with holidays, recommend the school administration to award students (diplomas, cash prizes, etc.) for active participation in cultural, social and sports events;
- 11.4. Expel students from the hostel for a gross offense;
- 11.5. To replace the chairman of the student council who has not properly fulfilled his duties;
