REGULATION on the scholarship of the OshMU academic council

1. General provision

The scholarship of the scientific council of OshMU will be awarded to the winners of the competition held in accordance with this regulation. The competition is organized once at the end of each academic year for students of the full-time department of OshMU. The main purpose of the contest is to encourage students who have demonstrated their activity in education, science, cultural mass, social, organizational and sports activities, as well as young talents, to encourage their development, moral and material support.

2. Tasks of the exam

2.1. Students are active in learning, social and organizational activities Encouraging participation;

2.2. Involvement in scientific research;

2.3. To identify the leading students of the university and to the public information about them.

3. Procedure for holding the test

3.1. The exam will be held in two stages. The first stage is held in faculties and colleges. Each faculty, college can propose no more than 2 candidates to the university commission until May 12. The second stage of the competition among candidates proposed by faculties and colleges will be held until May 17. Students are evaluated according to two criteria: the student's academic achievements and extracurricular social activities. Competition results 3.3. 4. Financial funding and awarding of winners 4.1. Financial

financing of the competition is carried out from the internal budget of OshMU.

4.2. The amount of the

total prize fund of this competition is determined annually by the Economic Planning Department and the Supervisory Board is determined.

4.3. The winners will be awarded with a one-time scholarship and certificate of the scientific council of OshMU.

5. Organizational group and its duties 5.1. The

1st stage of the exam is organized by the faculty, the deputies for educational affairs in colleges and the student council, and it is sent to the university commission. 5.2. Organizes and conducts award ceremony

for winners.

6. Composition of the

Commission 6.1. The organization and conduct of the 1st stage is carried out by the commission approved by the order of the head of the structure. The commission consists of representatives of the faculty/college responsible for educational and scientific activities, the head of the professional bureau, curators,

representatives from teachers, women's council, student council, student ombudsman office.

6.2. The organization and conduct of the 2nd stage is carried out by the commission approved by the order of the rector. The composition of the commission includes representatives from the vice-rectors, the professional association, the women's council, the sports club, the student council, and the office of the ombudsman.

6.3. The work of the commission is recorded and the decision is discussed not taken.
