



## Agreement

This agreement is made on **09/05/2023** by and between <<Asian Medical Students' Association, Kyrgyzstan>> OR <<AMSA-KG>> AND << OSH State University>> This agreement is valid until August 2025.

**PURPOSE OF AGREEMENT:** This agreement is based on the —*Constitution of AMSA-KG*— and in accordance with the —*Article V Section 2 of the Constitution of AMSA-KG*—. Constitution of AMSA-KG is in the Annex 1 to this Agreement, which is the integral part of the Agreement.

### TERMS AND CONDITIONS

#### 1. Membership:

- a. AMSA-KG shall be composed of Local Member Organizations, herein after referred as LMO, which are recognized medical student organizations from various medical universities.
- b. LMO wishing to be a part of AMSA- KG is compelled to sign the bilateral agreement with AMSA- KG on approval of administration of their respective universities.
- c. Another student organization from the same university cannot apply for the membership, as long as there is an existing LMO from the same school or college, unless the existing LMO's membership has already been terminated.
- d. For the initial time period AMSA-KG will provide Candidate Membership till NMSC 2023. Further the successful activation of Standing Committees in particular LMO full membership will be provided.

#### 2. Funds and Sponsorships:

- a. AMSA-KG is financially supported by International Higher School of Medicine until the association becomes a well-established ( till 2022 ). After to that the annual dues to the IFMSA and other expenses must be equally divided between

the LMOs. LMOs must take part in finding sponsors for the activities of AMSA-KG.

### 3. Responsibilities

- a. LMO should organize projects aligned to the advocacies and thrusts of the different standing committees of AMSA-KG.
- b. LMO has the duty to organize local activities for the development of their local communities.
- c. LMO should update the AMSA-KG Executive Board through the Internal Vice-President at least once every two months, concurrent with the provisions regarding their projects, events, and other important matters.

### 4. Termination

- a. In order to terminate of membership to the AMSA -KG, its president or its highest-ranking officer should state a formal letter addressed to the Executive Board of AMSA-KG stating the reason behind the membership withdrawal through the Internal Vice President.
- b. This letter should be duly signed by all of the organization's officers as well as its faculty adviser, if applicable. The Executive Board should approve the termination within a month after receipt of letter.
- c. The annual due (membership fee) of any LMO is not refundable after the termination.

### 5. Additional Terms

Any member of any LMO can be subjected to impeachment and thus removed from AMSA-KG upon:

- a. Violation of the constitution of AMSA KG.
- b. Failure to perform his / her duties as defined in the Constitution of AMSA-KG
- c. Disgraceful Acts, which are contrary to the principles of AMSA-KG
