

Osh State University Students' Introductory, On-the-Job and Qualifying Internship

AGREEMENT No 1

Osh city

“ 18 ” *march* 2023 y.

We, the undersigned, the Rector of Osh State University, Professor G. K. Kozhobekov henceforth will be called as "OshSU", and Director of S.Yu. Yunusov Institute of Chemistry of Plant Substances, Professor Sh.Sh. Sagdullaev, henceforth will be called as ICPS, in line with the requirements for the organization of practical trainings and internships for Osh State University' Students, the following agreement was concluded.

1. "OshSU" undertakes to:

- 1.1. Recommend and schedule work programs and sessions for different types of internships in order to advance the internship work;
- 1.2. Appoints a Head of Practical Trainings and Internships from the specialized department;
- 1.3. Conduct guidance and final conferences of practical trainings and internships;
- 1.4. Organize scientific and research seminars together with on-the-job practical trainings;
- 1.5. Regularly cooperate with medical institutions in conducting conferences, educational-methodical seminars, cultural and mass events.

2. ICPS obliges to:

- 2.1. According to the calendar plan, give 10 places for students of the Faculty of Medicine "Pharmacy" specialization;
- 2.2. Introduce rules on labor and occupational safety for students;
- 2.3. According to the internship program, introduce students with the necessary documents;
- 2.4. Introduce students of the Faculty of Medicine with the work plans of enterprises and their activities, as well as appoint specialists to lead their internship programs;
- 2.5. If the student takes a paid job or intern position during his internship period, he can apply the rules of protection of the general legal regulations applicable in the enterprise and the rules of observance of internal labor order in a certain manner;
- 2.6. After completing the Introductory, On-the-job and Qualifying Internships, we oblige to give a characteristic description for a student based on the work performed, and reports prepared by him.
- 2.7. Give suggestions and proposals to educational institutions for conducting qualitative internships.

3. Responsibility of the parties in performing the agreement:

- 3.1. The parties are responsible for fulfilling the tasks set for carrying out internships based on the labor laws of the Kyrgyz Republic and Republic of Uzbekistan;
- 3.2. Disputes regarding the Agreement between the parties shall be resolved within the framework of law;
- 3.3. The Agreement shall enter into force after the first party "OshSU" and the Second party "ICPS" signed;
- 3.4. The term of the Agreement is 1st april 2023 - until _31th of march 2028;
- 3.5. The Agreement is drawn up in two copies, one is kept at "OshSU" and the other at "ICPS".
