In accepting this grant and signing this award letter, you agree to do the following:


- Review and follow the project implementation procedures, with the understanding that failure to do so may disqualify you from participating in U.S. Government-sponsored grant and scholarship programs in the future.
- Attend the Project Management Workshop on **September 15, 2024**.
- Successfully implement the project in accordance with the proposal submitted to and approved by American Councils, with no activities extending beyond **January 31, 2025**.
- Request additional approval before making any amendments to the project plan or budget, according to the project implementation procedure.
- Spend **100% of the grant awarded to you no later than January 31, 2025**, in accordance with the approved budget, or an amended budget subsequently approved by American Councils.
- Submit all required reporting documents, photographs, and original receipts in two weeks after project's completion.
- Actively use social media for visibility of your project following the requirements in the project implementation procedures.
- All materials produced pursuant to the award (training, press, event materials, posters, videos, articles) must be marked appropriately with the standard rectangular U.S. flag and American Councils' logo.
