



# AGREEMENT OF COOPERATION

Osh State University, Kyrgyzstan

and

Vilniaus kolegija/University of Applied Sciences, Lithuania

#### **PREAMBLE**

According to the mutual wish to promote international cooperation in order to strengthen the role of universities of Eastern and Central Europe in the European Area of Higher Education and to exploit the most effectively research potential in the European Research Area the undersigned Rector of Osh State University and Rector of Vilniaus kolegija/University of Applied Sciences, execute this scientific, educational and cultural cooperation Agreement in compliance with the Bologna declaration.

#### **OBJECTIVES**

Osh State University and Vilniaus kolegija/University of Applied Sciences enter into the following terms of Agreement to develop mutually successful academic, pedagogical, scientific and technological cooperation that shall contribute to the academic and cultural benefits of both nations.

#### **IMPLEMENTATION**

The main purpose of this Agreement is to enlarge the relations of both institutions based on the friendship and different forms of cooperation between scientific teams of the faculties and departments through their Chief Executive Officers.

Both institutions shall engage in exchanges of academic staff, researchers and students. Both institutions shall act to develop joint research projects and a broad range of scholarly and educational exchanges.

Each faculty of both parties, through their Chief Executive Officers or their designate will promote implementation of this Agreement. The needs of both parties shall be registered, reviewed and coordinated through the efforts of the designated individuals. Particular forms of cooperation between Osh State University and Vilniaus kolegija/University of Applied Sciences will be entered into Complementary Agreements under this Agreement.

### FINANCIAL ARRANGEMENTS

Each of the both parties bears the total costs for the accomplishment of accepted activities and operating programmes between the faculties and departments in accordance with the particular Complementary Agreements under this Agreement.

The coordinators of the projects shall negotiate the financial resources necessary for the accomplishment of tasks, activities or projects within the reciprocal support of both parties.

## TERMINATION OF AGREEMENT

The Agreement will take effect immediately once signed and is validated for 5 years. Both parties shall discuss and decide on the continuation or revision of the Agreement six moths prior to its expiration.

The present Agreement is signed in four copies in English language. Each party shall retain two copies.
